



Student Disclosure of Criminal Convictions and Consent to Obtain Additional Information

Instructions

Requirement to Disclose

As part of its application for housing in its residence halls, the School of the Art Institute ("School") requires you to complete this form and disclose information regarding any criminal convictions that you may have.

Reason for Requirement

The School has this requirement to determine whether a student may be appropriately placed in the residence halls.

School's Use of the Information Disclosed

The existence of a conviction does not necessarily mean that a student will be denied permission to live in the residence halls. Each case will be evaluated on its facts. In making any determination based upon any disclosure, the School will consider, among other things, the nature, circumstances and severity of the crime and when the crime occurred and will weigh such factors against the interests and needs of the School with respect to housing. In addition, the School will carefully consider the responsibility and repentance of the person convicted.

Full Disclosure Required

You must complete this form to the best of your ability. This means that your answers must be truthful, accurate, and complete.

Consequence of Failure to Disclose

By your signature below, you certify that you understand and agree that your failure to disclose material information in response to this form may result in immediate suspension or expulsion from the residence hall and/or the School.

Continuing Duty to Disclose

By your signature below, you certify that you understand and agree that you will notify the School immediately of any inaccuracies in, or corrections to, the information you disclose here. You also certify that you understand and agree that you have a continuing duty to notify the School of any criminal conviction you receive subsequent to this initial disclosure. This duty will end only when you no longer live, or seek to live, in the School's residence halls.

Definition of Criminal Conviction

You must disclose any instance in any state or country where you have plead guilty or were found to be guilty by a judge or jury to charges that you committed a crime other than minor traffic offenses. This includes any 1) plea of offense; 2) juvenile, nolo contendere, or no contest pleas; and 3) any conviction that you are currently appealing.

This does not include any arrest or criminal history record information ordered expunged, sealed or impounded under applicable law or any conviction reversed on appeal.
